At about 11:10 PM four boys, that appeared to be teen aged, were captured on a neighbor's video security cameras in the area. In one seen, an individual can be seen hiding behind a tree near the sign as a car was going by on Branscomb Rd.

The same night, two mailboxes were knocked down on Branscomb east of the Community Center.

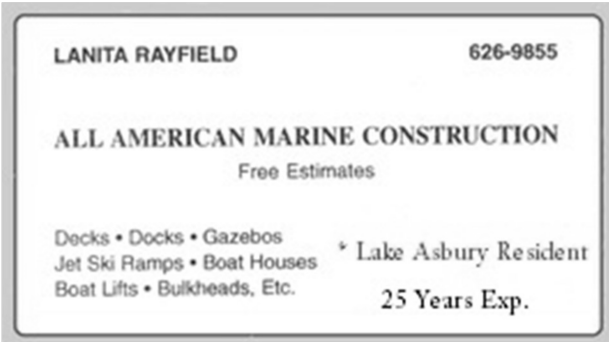

Updates from LA MSBD

Monitoring of lakes and shorelines for invasive and nuisance vegetation continues on a bi-monthly basis.

Mechanical extraction and chemical treatment of invasive vegetation along the shorelines of Lake Asbury and South Lake Asbury continues on an as-needed basis.

The board would like to remind all boaters about the importance of preventing the introduction of invasive and nuisance vegetation into our lakes. This is as easy as making sure that after a boat (and its trailer) has been in another body of water (ie: St Johns River, Black Creek, etc.), both are rinsed with clean water BEFORE the boat and trailer are put back into one of our lakes.

The board is pursuing Federal/FEMA grant fund sources to help offset the cost of the dams.
